The current bus that we are tranelling by was given to the students and faculty members assuring that it's be replaced by another one after six months. But nothing was brought into action. Though we never requested for a new bus, we definitely request the management to provide us a better bus to travel. There are members of bus who travel about 45-50 mins twice day which would cause a lot of inconvenience due to the pathetic condition of the bus.

I would want to draw your kind attention lowards the the condition of the bus, where there are many seats that would facilitate a person to sit, since the bus is old its maintenance has become a problem. The windowpanes are not functioning properly and tend to open on its own and in many cases season, it becomes difficult to drawel in such buses. dince they are found jammed. During winter of in rainy the bus seats are made up of or courd by a cloth wit often gets wet that would lead to shortage of seats as it becomes impossible to sit on it. The willing of the buses are often that helps the water penetrale easily inside due to which every passenger trude to get partially drenched in rain.

Also, seats in the bus are in bad condition and in a bad shape that causes numerous of physical aches. Most of the bold buses plying on long routes are seldon on time. Sometimes there's a problem in the engine and sometimes the type needs to be changed. Plus, thining such bus for the driver has also been a very tedious job due to janining of the bus handle causing a tough job for the deiner how. Hence the condition of the students & the faculty traveling by such buses has become pitiable Through these columns I request the authorities to look into the matter and redress the greevances of the passengers travelling by route No-12.
