TERMS AND CONDITIONS

1. Gaius being a start-up will utilise its platform, Gaius App for Training and Internship programs for students and faculty of the Institute.
2. The institute is desirous of entering into an agreement with Gaius to conduct Auxiliary Training and Internship opportunities for the students of the Institute.
3. The trainings will be conducted online by Gaius and will be published by Gaius. The initial offering of practical training courses will be in the areas of
 - a. AI, Machine Learning and Data Science
 - b. Networking and Cloud Technologies
 - c. Python
 - d. Web Development
 - e. Career Skills
1. **Pricing.** Students will be charged per session. Sessions will be typically around 2 hours. Many of the training areas will have multiple levels or sessions. The latest workshop details including price per session will be available in the Gaius classrooms site - <https://india.gaiusnetworks.com/workshops>.
2. **Registration and Payment** Students can register and pay online at <https://india.gaiusnetworks.com/workshops>.
4. **Internship Opportunities.** Students who have undertaken these trainings will be eligible for the Internship and Job referral program developed by Gaius in collaboration with other recruiters and companies. There will be no separate fee for these students to participate in the internship and job referral process. Each student will get 2 opportunities to participate in the internship and job referral process. Gaius is only responsible for making referrals; the final decisions are made by the individual recruiters and companies.
5. **Gaius will ensure**
 - a. Availability of faculty / speaker for trainings
 - b. Online Registration and Payment process
 - c. Feedback to institute on student performance
 - d. Communicate on internship opportunities and feedback
6. **The institute will ensure**
 - a. Communication to students about Gaius programs
 - b. Venue, infrastructure and coordination in case of contact programs
7. **Publicity.** Each party can communicate with the press or public regarding this Agreement, or the parties' relationship under it, after prior written consent from the other party.
8. **Term.** This Agreement will commence as of the Effective Date and will continue for a period of 1 year (the "**Initial Term**"), renewing automatically and perpetually for consecutive 1-year periods thereafter (a "**Renewal Term**"), subject to termination rights.
9. **Termination.** Either party may terminate this Agreement at the end of the Initial Term or renewal term or if either party provides written notice to the other at least 90 days prior to the end of the Initial Term or Renewal Term.
10. **Jurisdiction and governing law.** The agreement shall be governed and construed in accordance with the law of India courts in Chennai will have jurisdiction over any dispute that may arise out of or pertaining to this agreement.
11. **Relationship of parties.** The parties are independent contractors and have no authority to act on behalf of or bind the other. This Agreement does not create an employment, agency or partnership relationship or grant a franchise.
