STATEMENT OF WORK (SoW)

This Statement of Work (SOW) made and effective this **15th June 2019** ("Effective Date") by and between **Acsia Technologies Pvt Ltd.**, a company with its principal place of business at Eighth Floor, Module-2802, Yamuna Building, Technopark ., SFZ (Phase -III), Kulathoor PO – 695583 (**hereinafter referred to as "Acsia"**) which term shall, unless it be repugnant to the terms and meaning hereof be deemed to its holding company, other group companies, mean and include its successors in interest and permitted assigns, represented by Jijimon Aloth Chandran, Director,

and

Prof P Joy Prabhakaran (hereinafter referred to as "Consultant"), which term shall, unless it be repugnant to the terms and meaning hereof, be deemed to include his successors in interest and permitted assigns.

Commercial terms and conditions

2. As the Consultant is an academican of **KS Institute of Technology (KSIT)** the invoice will be raised by KSIT & the Consultant has given consent to transfer the Monthly remuneration to the Bank account of KSIT.

3. The Consultant will be available at Acsia Trivandrum office consecutively for two days in a fortnight (four days in a month).
4. Acsia will bear the Flight Charges for one visit in a month, in addition to the Monthly remuneration.
5.
